



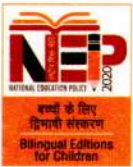
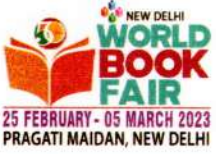

M/s Freebies Hub, Jaipur has not enclosed the copies of the work order and completion certificate.
2.	Work Order No.2581 dated 16-8-2023 from Executive Engineer, PWD Dn. Dungarpur for Rs.66,23,335/-	As per the letter No.EED/TA/D-1676 dated 26-7-2024 from Executive Engineer, PWED D. Dungarpur, the following are the comments: i) Letter number has been changed from 2531 to 2581 ii) Letter is clearly altered and no work order was ever issued from their office and no agreement was signed. iii) the work mentioned in the letter of acceptance was cancelled due to inevitable reasons and Firm M/s Freebies Hub, Jaipur has not executed any tent age work or barricading work or any miscellaneous work.	Enclosed copies of Notice Inviting Bid No.05/2023-24 (No.985-92 dated 19-6-2023), BoQ and computer generated e-Procurement system, but no work order and completion certificate are enclosed.
