### II. Last Date of Submission

1. Entries will not be accepted in the NBT Rights Catalogue after **20 August 2019**.

2. Only 10

1. The selection of books will be undertaken after the screening process by a Committee. The books which do not find a place in the Rights Catalogue will be returned to the publisher.
2. The National Book Trust, India will not be responsible for any copyright infringement during or after the publication of the information in the Catalogue, which is to be distributed at the Guadalajara International Book Fair 2019.

Kindly note that the **PDF version of the Rights Catalogue will be sent to prospective Spanish and other international publishers** participating in GIBF **by 15th October 2019 to elicit Rights enquiries and enable match-making meetings/sessions** during the Guest of Honour Presentation by India at the Fair.

3. Books should be published in India only. Foreign books reprinted in India will not be considered.
4. The list of books should be submitted in the attached format along with the books.
