The National Book Trust, India herein after called the Purchaser, proposes to obtain sealed bids from reputed firm/manufacturer, registered Micro and Small Enterprise who are manufacturers of Corrugated Cartons Boxes & Corrugated rolls in accordance with the specifications and terms and conditions provided herein after.

1. General:

2.0 Pre Qualification requirements: This Tender is based on Two bid system. The Tenderer shall submit his bid in two separate envelops marked "Technical Bid – Part A" duly sealed and super scribed as technical bid for supply of corrugated carton boxes & corrugated rolls and the second one marked "Financial Bid – Part B", duly sealed and super scribed as financial bid for supply of corrugated carton boxes & corrugated rolls and the second one marked "Financial Bid – Part B", duly sealed and super scribed as financial bid for supply of corrugated carton boxes & corrugated rolls The contents of the "Technical Bid – Part A" shall be as follows:

2.1 Technical bid – Part A: This shall form the basis of ascertaining the Technical and Financial credentials of the tenderer and also the suitability of the carton boxes/corrugated roll supplied by him in terms of the Structural and quality parameters. The Industry Standard, structural and quality parameters will be followed. However the NBT, India reserves the right to set higher standards for these parameters. The technical bid will be evaluated in terms of Anexture-II and all other relevant clauses of this Tender document. The tenderer shall provide a satisfactory evidence to show that:

a) He has technical knowledge and practical experience;

b) He has financial stability and status to meet the obligations under the contract.

c) He has plant and capacity to provide the service/ material within the time stipulated in the tender;

d) He has established quality control system and organization to ensure that there is adequate control at all stages of the service/production process.

e) All the relevant documents to support the above claims and any other documents that he deems fit are necessary to give sufficient evidence of his Financial and Technical capabilities.

2.2 Financial bid - Part B: This shall consist of Offer Form for Financial bid and duly filled in the format specified herein in accordance with the instructions and other relevant provisions mentioned in this tender document.

2.3 Documents to be submitted by Tenderers:

With the Technical bid – Part A:

(a). All the details/relevant documentary evidences as per Technical Criteria (Annexure –III) duly stamped, dated, and signed.

(b) All the tender papers should be serially numbered. The Page No.1 (One) of the tender document should be kept as page no. 1 (One).

c. All the documents, in support of Technical Bid – Part A should be self attested certified by the representative of firm.

II. With Financial bid – Part B:

a. The Offer form (for Financial Bid - Part B) (Annexure - IV) duly Stamped, dated and signed.

3. Both the bids should be sealed in two separate envelopes. The envelope containing Technical bid should be clearly marked "TECHNICAL BID – Supply of Carton Boxes and Corrugated roll" in bold capital letters. The envelope containing Financial bid should be marked "FINANCIAL BID – Supply of Carton Boxes and Corrugated roll" in bold capital letters".

Technical Bid. and Financial Bid should be put together in a single sealed envelope and duly super scribed as "Tender for Supply of Carton Boxes and Corrugated roll". Envelope containing the Tender to be addressed to:

4.Financial bids of only those bidders who successfully qualify in the technical bid will be opened on the same day as specified above. Bids not accompanied by required enclosures will be rejected without assigning any reason.

5.0 Tender Evaluation: The entire process of evaluation of the offers shall be in two stages:

5.1 Stage I: The Technical bid of all the offers that are received within the date and time mentioned herein shall be opened in presence of those tenderers or their authorized representatives who choose to be present at the time of opening of the tender. The Financial bid shall be put in a separate sealed cover signed by the authorized signatory of the tender. The technical suitability of the tenderers shall be evaluated based on the verification of the document submitted by tenderer with the technical bid. The financial bid of only those tenderers shall be opened who are shortlisted in stage I.

5.2 Stage II: The date and time of opening of the Financial Bid – Part B shall be opened at same date in the presence of shortlisted tenderers or their representatives who choose to be present. In addition, the following shall also apply.

a) During tender evaluation, NBT may, at its discretion, ask the Tenderer for a clarification of its tender. The request for clarification and response shall be in writing, and no change in the price or substance of the tender shall be permitted in response.

b) The tenders received will be evaluated by NBT to ascertain the lowest acceptable tender in the interest of NBT, as specified in the specification and tender documents.

Evaluation criteria not mentioned herein but mentioned specifically in the technical specifications will be taken into consideration in the evaluation of the offers and shall form part of the instructions.

6.0 Rates

The tenderers should quote base rates and GST, as applicable on the date of opening of tender. The offers with rates quoted inclusive of GST will be rejected. The amount of GST, if applicable should be separately mentioned.

6.1 The rates finalized against this tender shall be valid for a period of 1 year from the date as mentioned in the letter of acceptance. During the currency of contract, NBT, India at its sole discretion, reserves the right to vary the contract more or less as per requirement at same rates, terms & Conditions of the initial orders without assigning any reason.

6.2 The rates finalized against this tender shall be valid for a period of 1 year from the date as mentioned in the letter of acceptance and it may further be extended for another 02 years on satisfactory performances, if tenderer agrees to supply in the same rate and same terms and conditions mentioned in the existing tender. During the currency of contract, Purchaser at its sole discretion, reserves the right to cancel the contract without assigning any reason.

6.3 Based on the quotation received from the bidders, NBT would fix the rates (lowest of rates quoted by the bidders i,e L-1 rates) for Corrugated carton boxes and corrugated Roll and would be circulated among the qualified bidders for their acceptance. On acceptance from the bidders, NBT would finalise a list of empanelled suppliers who would be assigned the job of supply of Corrugated Carton boxes and corrugated Roll on order to order basis. No compromise would be entertained with regard to quality of materials.

7. Tenders are non transferable. The NBT, India reserves the right to reject any or all of the tenders in part or full at his sole discretion without assigning any reasons.

8. Offers sent by post should be by 'Registered post'/'Courier' /speed post with acknowledgement duly addressed to at the address mentioned hereunder. However NBT, India shall not be responsible for any postal delay. All tenders received after the stipulated time and date may summarily be rejected. Tender to be submitted to:-

9. Offers shall be as per terms and conditions and specifications given in the tender document. No deviation shall be allowed from the specifications, terms and conditions stipulated in the tender

10.0 Earnest Money & Security Deposit

10.1 Tenderers shall be required to deposit Rs. 90000/-(Rupees Ninety Thousand only) as earnest money (refundable) in the form of demand draft in favour of National Book Trust, India, Payable only at Delhi/ New Delhi. Tenders not accompanied by the requisite Earnest Money shall be rejected.

10.2 The successful bidder has to deposit performance security (in the form of Demand Draft) in favour of "National Book Trust, India drawn on any commercial bank payable at New Delhi a sum equal to 5 percent of the total value of the stocks detailed in the contract for which the tender has been accepted, subject to a maximum of Rs. 2, 25,000/- (Rupees Two lakh Twenty Five thousand only) as a security (refundable) for the due fulfillment of the contract. Performance Security Deposit of successful tenderer shall be retained till the conclusion of the contact. No interest will be payable on the Security Deposit. EMD already deposited may be adjusted against the performance security deposit.

11.0 Acceptance of tender:

11.1 NBT reserves the right to reject any or all of the tenders in part or full on its sole discretion without assigning any reasons.

11.2 NBT, India does not pledge itself to accept the lowest or any tender and reserves the right of acceptance of the whole or any part of the tenderer. The decision of NBT with regard to allotment of quantity so as to ensure uninterrupted supply of cartons will be final and binding. The tenderers shall supply the whole quantity at the quoted rate.

11.3 The award of tender will be issued by NBT, India on acceptance of offer letter from the tenderer concerned.

12. Quality & Rejections

Each supply should be made according to the specification under technical parameter as mentioned in the tender form. (Annexure II)

As cent percent inspection is not possible or practicable at the time of supply, the contractor shall replace the defective material at his own cost. Defective material if found afterwards on physical inspection and testing. If the same are not replaced in the reasonable time, the cost thereof will be recovered from contractors' subsequent bills.

13.1 Stock

The contractor has to supply the goods within the time frame specified in the work order.

13.2 Failure and Termination.

If the Contractor fails to deliver the materials or any installment thereof within the period fixed for such delivery in the contract or as extended or at any time repudiates the contract before the expiry of such period the NBT, India may without prejudice to its other rights

(a) recover from the Contractor as agreed by way of penalty a sum equivalent to 2 percent per week or part thereof of the price of any stock (including elements of taxes, duties, freight, etc.) which the Contractor has failed to deliver within the period fixed for delivery of such stock.

(b) Cancel the contract or a portion thereof and if so desired purchase or authorize the purchase of the stock by other empanelled suppliers.

14.Events of default

In the event of any breach of the said terms and conditions of the Contract, the NBT, India shall be entitled to forfeit the whole or the part of the security deposit besides terminating or revoking the contract.

15.Validity of Rates .The rates quoted under this tender shall be valid for at least 90 days from the date of opening of the tender. In case National Book Trust, India calls for negotiations, such negotiations shall not amount to cancellation or withdrawal of the original rates, which shall be binding, on the bidder. All expenses for attending such negotiations are to be borne by the bidder.

16 Only the courts in New Delhi/ Delhi shall have the Jurisdiction over any disputes.

17. Successful bidder would be given maximum fifteen (15) days time or less time, as the case may be, from the date of issue of the letter of award of contract, for payment of the Security Deposit (if any) and to convey his acceptance of award of contract. In case the successful bidder fails to accept the offer of award of contract, his EMD shall be forfeited by NBT, India. The manufacturer shall be debarred from participating in the future tender of NBT, India for a period of one year or more as will be decided by the Competent authority of NBT, India.

CHARACTERISTICS OF CORRUGATED CARTON BOX:-

1. The Corrugated Carton Box shall be seven ply board flutes and flute direction should be vertical.

2. Minimum 150GSM of liner Kraft Paper "A" grade shall be used for the manufacturing of the corrugated Box.

3. The adhesive used shall be strong enough to bond with the paper and of low moisture absorbency, so that the ply will not be distorted when come in the contact of moisture.

4. The outer surface of the box shall be water resistant; nevertheless the outer surface shall be capable of holding Turpentine solvent based Stencil Ink/ permanent maker pen ink.
