National Book Trust, India (NBT), an autonomous organization of the Government of India, Ministry of Education, invites sealed Bids/Quotations from registered and reputed firms in the prescribed Tender Form for Construction of NBT's Book shop at Kashmere Gate Metro Station New Delhi as per specifications for Scope of Work given in Annexure-II and Annexure-III (as per DMRC guidelines). Last date for submission of the Bids is 10.12.2020 upto 11:00 a.m.

# **TERMS AND CONDITIONS**

# 1. Eligibility Criteria

- 1.1. The Bidder should have at least 3 years' experience of working with Central/State Government or Public Sector Undertaking or Autonomous bodies of Central/State Government or National Level Professional Bodies in India of providing similar services. A certificate to this effect must be submitted. Experience of Private Organization shall not be considered at all.
- **1.2.** Bidder should have handled turnover of aggregate billing of minimum Rs.50 Lakh per annum during each of the three preceding years.
- **1.3.** Bidder must have sufficient and qualified supervisory staff to ensure providing of satisfactory Construction/ Fabrication services to NBT.

# 1.4. Essential Parameters for Qualification in Technical Bids:

- Self-attested copy of PAN card.
- Self-attested copy of MOA/AOA/Deed/ Bye Laws.
- An Affidavit on Rs.100/- stamp paper duly signed and stamped by Notary (Required to be enclosed and Photocopy of the affidavit will not be accepted) stating that:-
  - "The Firm has not been Debarred or blacklisted by Government, Quasi Government, PSU or Autonomous Organization".
  - "Bidder has not defaulted on any bank/financial institution loans in the past. There should not be any statutory dues or disputed liability".

- Specimen signature, name, address, contact no., designation/capacity of the person signing the tender document on letter head are required to be enclosed.
- Experience Certificate as per clause 1.1 above from the Administrative Head of the unit where services were provided or Work Order & completion certificate should be enclosed.
- ➤ Certified copy of Income Tax Returns, Profit & Loss Account and Balance Sheet with Annexure for the last 3 financial years i.e. 2017-18, 2018-19 & 2019-20.
- The Firm should have valid license from authorities concerned/ Govt. regulatory bodies (Self attested copy of Certificate to be enclosed).
- ➢ GST Return copy for the financial year 2020-21 and Self-attested copy of GST Registration.
- Performance Security will be 10% of the value of contract after getting of Contract.
- Demand Draft for Earnest Money Deposit of Rs.50,000/-.

# 2. Two Bid system tender

Separate Technical and Financial Bids duly sealed and superscribed as "Technical Bid for Construction of NBT's Book shop at Kashmere Gate Metro Station New Delhi" and "Financial Bid for Construction of NBT's Book shop at Kashmere Gate Metro Station New Delhi" should be submitted as per Bid details given in the document and addressed to Deputy Director (Admin), National Book Trust, India, Nehru Bhawan, 5, Institutional Area, Phase-II, Vasant Kunj, New Delhi – 110070, must reach on the above address latest by 11:00 hrs on 10.12.2020.

The Tender not submitted in the prescribed format(s) or incomplete in any respect is liable for rejection. NBT is not responsible for non-receipt of bids/quotations within the specified date and time due to any reason including postal delays, holidays etc.

# Envelope – 1 (Technical Bid):

The Technical Bid should be complete in all respects and contain all the required information except rates. The Technical Bid should include all the components asked for in Annexure I. The format prescribed for submission of Technical Bid is as under:

- Covering letter
- EMD in the form of an Account payee Demand Draft drawn in favour of "National Book Trust, India" payable at New Delhi, for Rs.50,000/-.
- The Company profile
- Experience/Details of operation in the last 3 years
- Duly signed copy of Tender Document
- Technical Documentation, if any
- All Documents mentioned under clause 1.4 and as per Annexure-I

# Envelope - 2 (Financial bid):

The Financial Bid should give all relevant price information as per Annexure –II. The bid form must be filled in completely, without any errors, erasures or alterations. The Financial Bid must not contradict the Technical Bid in any way.

#### 3. Documentation

The Bidder shall furnish, as part of his tender, documents establishing his eligibility to participate in the tender and his competence to perform the Contract.

# 4. Earnest Money Deposit

Bidder must submit Earnest Money Deposit (EMD) of Rs.50,000/- (Fifty thousand only) in the form of a Demand Draft drawn in favour of "National Book Trust, India" payable at New Delhi.

#### 5. Costs

The Bid should include the following

- Rates of services or other additional items, if any, should be inclusive of all taxes and statutory levies.
- Rates Quoted: The Bidders should quote rates only in Annexure II

# 6. Preliminary Scrutiny

NBT will scrutinize bids to determine whether they are complete, whether any errors have been made in the Technical Bid, whether required technical documentation has been furnished, whether the documents have been properly signed, and whether items are quoted as per the schedule. NBT may, at its discretion waive off any minor non-conformity or infirmity in a bid provided such waiver does not affect relative ranking of other bidders. The decision of NBT in this regard will be final & binding.

# 7. Clarification on Bids

To assist in the scrutiny, evaluation and comparison of bids, NBT may, at its discretion, ask some or all vendors for clarification on their bids. The request for such clarification and the response will necessarily be in writing. If deemed necessary, the bidder may be required to give presentation on the proposed Bid.

# 8. Technical Inspection and Performance Evaluation

NBT reserves its right to carry out a technical inspection and performance evaluation (benchmarking) of the Bids made by short listing eligible Bidders. This may also include site inspection of the current engagements of the Bidders.

# 9. Verification

NBT reserves the right to verify any or all statements made by the Bidder in the tender document and to inspect the Bidder's facilities, if necessary, to establish to its satisfaction about the vendor's capacity to perform the job.

# 10. Short listing of bidders

NBT will make a list of technically qualified Bidders. The Financial Bids of only such qualified Bidders will be opened.

#### 11. Cancellation of contract

NBT reserves the right to cancel the Tender process /Contract without assigning any reason.

# 12. Legal Jurisdiction

The Contract shall be deemed to have been concluded in the National Capital Territory of Delhi and all obligations hereunder shall be deemed to be located at the NCT of Delhi and the Court within NCT of Delhi only will have jurisdiction to the exclusion of all other Courts.

- 13. Income Tax as applicable will be deducted at source
- 14. TDS under GST as applicable will be deducted at source
- 15. The Contractor shall provide the following services in Kashmere Gate Metro Station New Delhi:
  - a) To provide Construction/Fabrication of NBT Book Shop as per specification for Scope of Work given in Annexure-II and Annexure-III (as per DMRC guidelines). The contractor will be responsible for removal and proper disposal of waste material, garbage etc.
  - b) The contractor will be fully responsible for any loss/damage at Kashmere Gate Metro Station New Delhi during the construction of NBT Book Shop and same will have to be made good by the Contractor at his cost.
  - c) The size and weight including quality of various items should be approved by NBT. No new items would be introduced without approval of NBT. No rate will be revised without prior approval of NBT.
- 16. It is necessary to provide copy of valid license from authorities concerned/ Govt. regulatory bodies along with the tender document.

# 17. Penalty clause

Failure to execute any job regarding construction/ fabrication of NBT Book Shop at Kashmere Gate metro Station New Delhi will render the Contractor liable to penalty as may be decided by NBT. The decision of NBT with regard to the quantum of penalty shall be final and binding on the Contractor.

# 18. Performance Security

Before award of the contract the successful Bidder will be required to deposit 10% of contract value as Performance Security (refundable) in the form of a Demand Draft drawn in favour of National Book Trust, India, payable at New Delhi. The Performance Security deposited by the Contractor will be retained till completion of the job. It will be forfeited by order of the Competent Authority of NBT, India in the event of any breach or negligence or non-observance of any terms/conditions of contract or for unsatisfactory performance of the job.

# 19. Change in Quantities:

The quantities mentioned in Annexure-II may be increased or decreased at the discretion of NBT and no claim in this regard will be entertained. **If considered necessary, any item could be dropped completely.** 

# 20. Handing over

After completion of the works, i.e. construction/ fabrication of NBT Book Shop at Kashmere Gate metro Station New Delhi, the site shall be handed over to NBT. The maintenance and upkeep of the items provided while undergoing the said construction would be responsibility of the Contractor(s). Contractor shall provide warranty/ guarantee on all the installed items for a period of **two years (twenty four months)** after its supply and installation, without any extra or additional cost to NBT, except any damage due to termite, water leakage, or any other fault caused to other factors which do not involve the quality of the furniture/ workmanship.

# **GENERAL TERMS AND CONDITION OF CONTRACT**

- 1. The tender shall be submitted on the prescribed tender application form.
- 2. If the cover of the tender is not sealed and marked, the NBT will assume no responsibility for the tender's misplacement or premature opening.
- **3.** The tenderer should clarify whether the individual signing the tender or other documents in connection with the tender signs as:

A "sole proprietor" of the firm or constituted attorney of such sole proprietor, or a partner of the firm if it be a partnership in which case he must have authority to refer to arbitration disputes concerning the business of the partnership either by virtue of the partnership agreement or a power of attorney. In the alternative, the tender should be signed by all the partners or Director in case of a Company.

The tender should be signed either by the proprietor or by his authorized representative. In case of the latter, an authority letter should be enclosed with the tender.

- 4. Incomplete tenders are liable to be rejected. It means Tenderer should quote for all items. If any item is missed or not quoted, the entire Tender will be rejected.
- 5. The quantities mentioned in the schedule may either be increased or reduced at the discretion of the NBT. However, for the reduced quantity no claim shall be entertained and if considered necessary, any item could be dropped completely.
- **6.** The tenderers should fill the rates both in figures as well as in words. The tender form may be filled in English and all entries must be handwritten in ink. Overwriting of rates is not permitted.
- 7. If there is a discrepancy in rates between words and figures, the amount in words will prevail.
- **8.** When deemed necessary, the NBT may seek clarification on any aspect from the tenderers. However, that would not entitle the tenderer to change or cause any change in the price quoted.
- **9.** The tenderers, in their own interest, are advised to inspect the layout of NBT Book Shop site at Kashmere Gate Metro Station before submitting tenders.
- 10. The NBT will examine the tenders to determine whether they are complete, whether any computational errors have been made, whether the documents have been properly signed, and whether the tenders are generally in order.

11. The NBT may waive any minor infirmity or non-conformity in the tender which does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of other tenderers. The decision of the NBT in this regard will however be final.

# 12. <u>Liquidated Damages</u>

Work must be completed with in 20 days from the date of award of the contract in all respects. Failure to do so will entitle the NBT to impose a penalty of Rs.10,000/per day on the contractor and he may be blacklisted for future work. In addition to it the Performance security deposits shall stand forfeited. Further, failure on the part of the contractor to complete the job in accordance with the terms and conditions set out and within the time schedule will confer on the NBT the right to get the work done through another contractor, in which event, the entire cost/damages so incurred by the NBT will have to be paid by the first contractor.

- 13. It will be the responsibility of the successful contractor to take a comprehensive insurance cover against fire, damage, pilferage, etc., at his own cost. He should take necessary precautions to safeguard against possible hazards/ accidents.
- **14.** The successful tenderer will have to get a Layout/Grid/Picture of the NBT Stalls approved by the NBT before execution of the work.
- **15.** The quality of material to be used for the construction should conform to the approved model/presentation. Any deviation in quality will render the contractor liable to penalty as may be decided by the Trust. The decision of the Trust in this regard shall be final and binding on the contractor.
- **16.** The contractor shall engage technically competent personnel for executing the work.
- 17. The NBT will award the contract to the tenderer whose tender has been determined to be substantially responsive and has been determined as the lowest evaluated bid, provided further that the tenderer is determined to be qualified to perform the contract satisfactorily.
- **18.** During the period of construction of NBT Book shop, the contractor shall have to make his own arrangement for various amenities necessary for the smooth execution of his work.
- **19.** The payment of the billed amount will be made subject to a physical verification by the officers of the NBT.

**20.** The decision of the NBT in this regard would be final and binding.

# 21. Opening of Tender

The Tenderer is at liberty either himself or authorize not more than one representative to be present at the opening of the tender. The representative attending the opening of the Tender on behalf of the Tenderer should bring with him a letter of authority from the Tenderer and proof of identification.

# 22. Criterion for Evaluation of Tenders

The evaluation of the tenders will be made first on the basis of technical and commercial information of the Firm/Agency. The Financial Bids of those firms which are found eligible based on technical parameters only will be opened. The reasons for selection or rejection of a particular tender will not be disclosed. The award of work will be further subject to any specific terms and conditions of the contract given in tender document.

The work will be awarded to the L-1 Bidder. In case the financial bid of more than one Bidder is same as L-1, the work will be awarded to the firm which is better in Technical evaluation.

# 23. Force Majeure

Neither party shall be in default if a failure to perform any obligation hereunder is caused solely by supervening conditions beyond that party's reasonable control, including acts of God, civil commotion, strikes, acts of terrorism, Labour disputes and government or public authority's demands or requirements.

# 24. Insolvency etc.

In the event of the firm being adjudged insolvent or having a receiver appointed for it by a court or any other order under the Insolvency Act made against them or in the case of a company the passing of any resolution or making of any order for winding up, whether voluntary or otherwise, or in the event of the firm failing to comply with any of the conditions herein specified NBT shall have the power to terminate the contract without prior notice.
