TERMS AND CONDITIONS

1. The quotation should be submitted in the form prescribed in Annexure – A.
2. If the cover of the quotation is not sealed and marked, will be rejected. Trust will assume no responsibility for its misplacement or premature opening.
3. Incomplete quotations are liable to be rejected.
4. Rates should be quoted specifying whether they are including or excluding GST and other levies. The safe delivery of consignments will be sole responsibility of the transporter which includes the carrier risk as per declared value in the GR.
5. The Tenderer should fill the rates both in figures as well as in words. The Tender form may be filled in English and all entries must be handwritten in ink or typed. Overwriting of rates is not permitted. Corrections, if any, should be attested by the authorized signatory.
6. If there is a difference in rates between words and figures, the amount in words will prevail.
7. When deemed necessary, the Trust may seek clarification on any aspect from the Tenderers. However, that would not entitle the Tenderer to change or cause any change in the rate quoted.
8. **Sealed quotations may be sent to Deputy Director (Store), NBT office Vasant Kunj, New Delhi office till 0200 PM on 12-07-2019.**
9. **Tender shall be opened on 12-07-2019 at 0330 PM in Trust's Vasant Kunj Office, New Delhi. Tenderer or their representative may like to be present at the time of opening of bid.**

10. Tenderers shall be required to deposit Rs. 40,000/- (Rupees Forty Thousand only) as Earnest Money (refundable) in the form of demand draft in favour of National Book Trust, India, Payable at Delhi/ New Delhi. Tenders not accompanied by the requisite Earnest Money shall be rejected.

11. Based on the quotation received from the bidders, the trust would fix the transportation rates of various states/destination and would be circulated to all the bidders for their acceptance from the transporters, the trust would finalize a list of empanelled transporters who would be assigned the job of transportation on order to order basis.

12. The empanelled transporters will be required to deposit Security Money (refundable) lump sum amounting to Rs. 75,000 (Rupees Seventy five Thousand) in the form of Demand Draft, drawn in favour of National Book Trust, India payable at New Delhi. The security money deposited by the empanelled transporters will be retained by the Trust till the validity of the contract and shall be returned without any interest on expiry of the contract.

13. Security Deposit shall, however, be liable to be forfeited if the contractor backs out after award of the job or fails to execute supply within the stipulated time or if the supply is not made satisfactorily as per the terms and conditions. The consignment of books is required to be lifted by the Transporter from NBT Godown, Vasant Kunj, New Delhi-70 / CWC Godown Sahibabad (UP) and to be door delivered at all India basis as per the instructions given in the letter of dispatch.

14. Validity of contract for tender will be for 03 (three) years and will be reviewed every year on mutual agreement and performance of the transporters.

NBT, India reserves the right to: -

14.1 Accept or reject any of the bid/all bids or cancel/withdraw the invitation for bid without assigning any reason whatsoever, and in such case no bidder/intending bidders shall have any claim arising out of such action by NBT, India.

14.2 Reject conditional tenders, tenders containing absurd or unworkable rates and tenders which are incomplete and otherwise considered defective and tenders not in accordance with the tender conditions, during the tender evaluation process.

14.3 Accept/Reject any or all tenders fully or partly, reduce/ increase business volume and number of contractors, split the award without assigning any reasons thereof.

Handwritten signatures and initials in blue ink, including a signature that appears to be 'Anurag' and another signature that appears to be 'A', along with the number '113'.

14.4 Cancel/terminate the contract at any time during its currency without assigning any reasons whatsoever.

15. The Transporter will be responsible for safety of the books during transit, loading and unloading. Full value of books (MRP) in case of loss or damage, if any during transit/door delivery, shall be recovered from the Transporter. The value of books declared in GR shall be the value of the consignment.

16. The books to be transported are exempt from GST.

17. The consignment must be delivered as per schedule mentioned in annexure "A".
Transporter has to be picking up the consignment within a notice period of 24 hours. If transporter fails to do so, the consignment will be handed over to next empanelled transporter. **Repeatedly** fails to pick up the consignment on stipulated time, the transporter **may be black listed**.

If Transporter fails to deliver the books within the stipulated time as mentioned in annexure 'A' , the Trust shall have the right to make an alternative arrangement at the cost and risk of the original transporter. Besides a penalty of Rs. 2000/- per day for the period of delay shall be imposed.

18. Consignments of 09 Tons and above will be considered as full truck load.
Tracking facility - To be provided in specific cases. But regular feedback of materials in transit and date of delivery of material at consignees' point should be provided to NBT, India's concerned person.

19. The Trust shall make the payment at its Delhi Office after the books are delivered in good and intact condition to the satisfaction of the Trust on production of **Dharam Kanta receipt and acknowledgement of consignment duly signed and stamped by the consignee. In case of non-submission of Dharam Kanta receipt from transporters, weight record sheet provided by NBT office will be considered final.**

19.1 Payment Terms : Our normal payment terms are 45 days from date of submission of your bills with acknowledged delivery challan / supporting documents.


19.2 Bill to be submitted along with the receipted LR within 15 days at our HQ, NBT, India, New Delhi from the date of delivery of material to the consignee.

20. Rates quoted for transportation by the Transporter shall **be inclusive of loading, unloading at NBT godowns and door delivery**. Conditional and unsigned tenders, tenders containing absurd or unworkable rates and amounts, tenders which are incomplete or otherwise considered defective and tenders not in

accordance with the tender conditions, specifications, etc., are liable to be rejected.

21. Goods once loaded to trucks are to be completely taken care of during whole of transit period to be covered with tarpaulin, rope etc. to prevent rain water, damage and look after from any damage / pilferage / loss / non-short delivery, wastage etc. till safe delivery to the destinations and obtaining CLEAN RECEIPT THEREOF.
22. The Trust may free to accept or reject any quotation, and to withdraw the whole tendering process or to reject all bids at any time prior to award of the contract and without incurring any liability to the affected Tenderers.
23. 2% TDS under (section 194 C) Income Tax as applicable shall be deducted by the Trust as per the norms of Government of India.
24. The Tenderer must mention the permanent Account Number (PAN), GST No. and other credentials. If GST no. not incorporated , GST amount shall not be paid.
25. **Validity of Offer** .The offer should be valid for at least 90 days from the date of tender opening. In case National Book trust, India calls for negotiations, such negotiations shall not amount to cancellation or withdrawal of the original offer, which shall be binding, on the bidder. All expenses for attending such negotiations are to be borne by the bidder.
26. All unresolved disputes shall be subject to the jurisdiction of Delhi/New Delhi Courts only.


