- D. The provided auto should not be more than 5 years old, should confirm to mass emission standard of Bharat Stage III or above and must be approved by The Transport Department of GNCT of Delhi.
- E. The auto rickshaw should be fitted with Electronic Fare Meter GPS/ GPRS integrated and duly approved, tested and sealed by the Controller, Weights and Measurement Department, GNCT of Delhi, certified by DIMITIS and the meter should be enabled to generate printed bills at all times.

"The period of contract will be for one year from the date of award of contract. This office also reserves the right to renew or extend the contract in periods of three (3)/ six (6) months, taking into account the satisfactory services rendered by the contractor during previous year.
